As a result of Mr Gernot Gauper's dishonest and unprofessional business ethics, Maitreya Kft. has terminated its Broker contract with Mr Gernot Gauper as of last Friday 28 August 2009.

It came to our attention that Mr Gauper was approaching other contracted World Brokers, and their customers, offering to sell devices below the official set price. In fact he is offering so called SCIO devices for less than wholesale price.

Maitreya Kft., Hungary, is the only current official manufacturer of the SCIO device in Europe. Maitreya Kft. supplies SCIO devices to all parts of the world except the USA. The official manufacturer of the SCIO device in the USA is SCIO USA. SCIO USA manufactures and supplies to the USA market. Anyone offering to sell the SCIO device at wholesale prices is doing so fraudulently. The official set price for the SCIO device is 15,000 EUR plus local sales tax. If you receive any such offers from Mr Gauper or any of his associates please forward to me at sue@qxsubspace.com so I can follow through with the necessary actions regarding these fraudulent offers.

The current official software for the SCIO is the 7.7.2009 Clasp 32 English software. This software is only able to be activated on the internet. These activations are successfully being carried out on a daily basis. At the moment the current stable German version of the Clasp 32 is 8-888-8. The German version of the software will also be available to download and activate online in the near future.

Mr Gauper has been spreading unfounded and slanderous lies and rumours about Maitreya Kft and it's financial relationship with its Hungarian manufacturing company. Please be assured that all SCIO device orders placed and paid for with our company have been fulfilled and all devices have been sent within a timely fashion, not exceeding 3-4 weeks from time of payment, as notified to the Broker at the time of ordering.


According to our company records Mr Gauper does not have stock of SCIO devices. Any person involved in the sale of second hand SCIO devices should follow the company policy
